1 INTRODUCTION

- 1.01 **Revision Date**: This Privacy Policy (the "Policy") has been revised on and is effective as of **May 5, 2015**.
- 1.02 **Website Use**: This website is operated by the Duke Angel Network ("DAN"), which respects your privacy and is committed to protecting it through this Policy. By accessing this website, dukeangelnetwork.duke.edu (the "Website"), you agree to be bound by the Policy. This Policy may change from time to time (see "Changes to the Privacy Policy").
- 1.03 **Application**: This Policy applies only to this Website. It does not apply to information collected by offline means or through any other means, including through any other website operated by DAN, Duke University or any third party.
- 1.04 **Duties of Users**: Please read this Policy carefully to understand these terms and practices regarding your information and how DAN will treat it. If you do not agree with DAN's policies and practices, your may choose not to use this Website.
- 1.05 **Information DAN Collects**: In general, you can visit our Website without revealing any personal information and this Website collects no personal information about you. We collect and log the IP address (an identification number associated with your computer) of all visitors to our Website. This allows us to administer our system and gather aggregate information about how our site is being used. To maintain your anonymity, we do not associate IP addresses with records containing personal information. We will use IP address information, however, as needed to enforce our legal rights or when required to do so by law enforcement authorities.

2.02 – **Payment**: When you initiate the process to pay your membership fees, the Website will direct you to a third-party payment service, which will collect your name, email address, billing address and credit card information (your "Payment Information"), the payment amount and date ("Payment Details"), and ask you to agree to the DAN Terms of Membership (your "Membership Agreement"). DAN does not maintain records of your Payment Information, but will keep a record of your Payment Details and Membership Agreement. It is your responsibility to acknowledge and accept the privacy policy of the Payment Service.

2.03 – **Our Use of Information provided by other Sites**: DAN uses other sites to facilitate DAN activities. These activities include obtaining personal information from users who submit an application for membership in DAN, providing information to DAN members, connecting individual DAN members and otherwise communicating with DAN members. If DAN obtains any personally identifiable information from any third party site, DAN will use that information only to facilitate DAN activities. DAN will not sell or give your information to any party except as necessary to facilitate communications among DAN members as contemplated by the Membership Agreement.
